This Japanese Industrial Standard has been revised by the Minister of Economy, Trade and Industry through deliberations at the Japanese Industrial Standards Committee as the result of proposal for revision of Japanese Industrial Standard submitted by Nippon Slag Association (NSA) with the draft being attached, based on the provision of Article 12 Clause 1 of the Industrial Standardization Law applicable to the case of revision by the provision of Article 14. Consequently JIS A 5011-1:2013 is replaced with this Standard.

However, **JIS A 5011-1**: 2013 may be applied in the **JIS** mark certification based on the relevant provisions of Article 19 Clause 1, etc. of the Industrial Standardization Law until July 21, 2018.

Introduction

This Japanese Industrial Standard was established in 1997 by integrating **JIS A 5011** (established in 1977) and **JIS A 5012** (established in 1981), and has been revised three times since then. A comparison table between previous and current editions of this Standard on technically significant revisions is given in Annex D.

No corresponding International Standard has been established at this point.

1 Scope

This Standard provides specification applicable to blast furnace slag aggregate used for concrete.
