Introduction

This Japanese Industrial Standard has been prepared based on the second editions of **ISO 1481**, **ISO 1482** and **ISO 1483** published in 2011, by editing and incorporating items (shape and dimensions, product specifications and designation of products) that correspond to **JIS** contents without modification of technical contents.

The portions given sidelines or dotted underlines are the matters not given in the corresponding International Standard. A list of modifications with the explanations is given in Annex JB

This Standard contains the following Annex, not given in the **ISO** Standards, for providing requirements that reflect the manufacturing and use of the product in Japan.

Annex JA (normative) Slotted head tapping screws with thread shapes and dimensions of Class 1 to Class 4

1 Scope

This Standard specifies the characteristics of slotted head tapping screws with thread sizes from ST2.2 to ST9.5 inclusive.

The characteristics of slotted head tapping screws with Class 1 to Class 4 threads that are not in accordance with **JIS B 1007** are specified in Annex JA.

NOTE : The International Standards corresponding to this Standard and the symbol of degree of correspondence are as follows.

ISO 1481:2011 *Slotted pan head tapping screws*

ISO 1482:2011 *Slotted countersunk (flat) head tapping screws*

ISO 1483:2011 *Slotted raised countersunk (oval) head tapping screws*
(Overall evaluation: MOD)

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standards and **JIS** are IDT (identical), MOD (modified), and NEQ (not equivalent) according to **ISO/IEC Guide 21-1**.
