# Hexagon head tapping screws

## Introduction

This Japanese Industrial Standard has been prepared based on the second edition of **ISO 1479**, published in 2011, by editing and incorporating items (shape and dimensions, product specifications and designation of products) that correspond to **JIS** contents without modification of technical contents.

The portions given sidelines or dotted underlines are the matters not given in the corresponding International Standard. A list of modifications with the explanations is given in Annex JB

This Standard contains the following Annex, not given in the **ISO** Standard, for providing requirements that reflect the manufacturing and use of the product in Japan.

Annex JA (normative) Hexagon head tapping screws with Class 1 to Class 4 threads

## 1 Scope

This Standard specifies the characteristics of hexagon head tapping screws with thread sizes from ST2.2 to ST9.5 inclusive.

The characteristics of hexagon head tapping screws with Class 1 to Class 4 threads that are not in accordance with **JIS B 1007** are specified in Annex JA.

NOTE : The International Standard corresponding to this Standard and the symbol of degree of correspondence are as follows.

ISO 1479:2011 *Hexagon head tapping screws* (MOD)

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standard and **JIS** are IDT (identical), MOD (modified), and NEQ (not equivalent) according to **ISO/IEC Guide 21-1**.
