Introduction

This Japanese Industrial Standard has been prepared based on the third edition of **ISO 3767-2** published in 2008 without any modifications of the technical contents.

Annex JA in this Standard is not contained in the corresponding International Standard.

1 Scope

This Standard establishes symbols for use on operator controls and other displays on tractors and machinery for agriculture as defined in **ISO 3339-0**.

The symbols given in this Standard are for controls and displays specific to agricultural tractors and machinery such as combine harvesters, cotton harvesters, and forage harvesters.

NOTE 1 Other symbols relating to specific forms of machinery and equipment are given in other parts of **ISO 3767**.

NOTE 2 The International Standard corresponding to this Standard and the symbol of degree of correspondence are as follows:

ISO 3767-2:2008 *Tractors, machinery for agriculture and forestry, powered lawn and garden equipment—Symbols for operator controls and other displays—Part 2: Symbols for agricultural tractors and machinery* (IDT)

The symbols which denote the degree of correspondence in the contents between the relevant International Standard and **JIS** are IDT (identical), MOD (modified), and NEQ (not equivalent) according to **ISO/IEC Guide 21-1**.
