Rerolled steel bars for concrete reinforcement

1 Scope

This Japanese Industrial Standard specifies requirements for the rerolled steel bars manufactured by hot-rolling that are intended for concrete reinforcement. Rerolled steel bars are classified into rerolled plain steel bars and rerolled deformed steel bars.

3 Terms and definitions

For the purpose of this Standard, the following terms and definitions, and those given in **JIS G 0202** and **JIS G 0203** apply.

3.1

steel bar

product manufactured by hot-rolling steel into a bar

Note 1 to entry This Standard classifies steel bars into plain steel bars (3.2) and deformed steel bars according to the sectional shape.

Note 2 to entry Steel bars include bars in coil (3.3).

3.2

plain steel bar

steel bar (3.1) having a circular cross-section
