1 Scope

This Japanese Industrial Standard specifies the requirements for liquid textured paints (synthetic resin emulsion type) mainly used for interior and exterior finishing of buildings ¹⁾, which are mainly made of synthetic resin emulsion and pigment or those added with a filler, and not containing formaldehyde system antiseptics, urea resin, phenol resin or melamine resin.

Note 1) There are such as stipple finish, orange-peel finish and lunar-surface finish.
