Test method for colour fastness to laundering with oxygen bleach

JIS L 0889: 2014

Introduction

This Japanese Industrial Standard was established in 1987 and has gone through two revisions up to the present. The last revision was made in 1998, and the revision at this time is to respond to the subsequent technical advances.

No corresponding International Standard has been established at this point.

1 Scope

This Standard specifies the test method for colour fastness of dyed textiles to be washed with oxygen bleach containing sodium percarbonate.

3 Terms and definitions

For the purpose of this Standard, the terms and definitions given in clause **3** of **JIS L 0801** apply.

4 Summery

A specimen is laundered with bleaching agent by the specified method, and the change in colour of the specimen is assessed with reference to the original fabric, either with the grey scale for assessing change in colour or instrumentally.

For the test method for colour fastness to bleach soaking and washing, it is recommended to see Annex C.

5 Apparatus and materials

The apparatus and materials shall be as follows.
