# Textiles—Determination of dimensional change

## Introduction

This Japanese Industrial Standard has been prepared based on the fourth edition of **ISO 3759** published in 2007 and the second edition of **ISO 5077** published in 2007 with some modifications of the technical contents by considering various situations concerning the washing of textiles in Japan.

The portions given sidelines or dotted underlines are the matters in which the contents of the original International Standards have been modified. A list of modifications with the explanations is given in Annex JA.

## 1 Scope

This Standard specifies the measuring method for the dimensional change caused by washing, dry cleaning, immersion, drying, finishing treatment, etc. of textiles. However, the fabrics and the floor coverings are excluded.

NOTE : The International Standards corresponding to this Standard and the symbol of degree of correspondence are as follows.

ISO 3759 : 2007 *Textiles—Preparation, marking and measuring of fabric specimens and garments in tests for determination of dimensional change*

ISO 5077 : 2007 *Textiles—Determination of dimensional change in washing and drying* (Overall evaluation: MOD)

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standards and **JIS** are IDT (identical), MOD (modified), and NEQ (not equivalent) according to **ISO/IEC Guide 21-1**.
