Sizing systems for women's garments

1 Scope

This Japanese Industrial Standard specifies the sizing systems and their indication methods for ready-made women's garments (except foundation garments).

3 Terms and definitions

For the purpose of this Standard, the following terms and definitions, and those given in **JIS L 0111**, **JIS L 0112** and **JIS L 0215** apply.

3.1

woman

female person whose growth in height is finished

Note 1 to entry A woman herein refers to a female person whose size corresponds to the control dimensions specified in this Standard.

3.2

man

male person whose growth in height is finished

Note 1 to entry See **JIS L 4004**.

3.3

ready-made garments

mass-produced clothes manufactured in specific sizes and designs as pre-determined by a manufacturer, targeting an unspecified number of people

size of ready-made garments

expression of size for ready-made garments as a whole

Note 1 to entry Indicated by the control dimensions and the specific garment measurements.
