Introduction

This Japanese Industrial Standard has been prepared based on the first edition of **ISO 22197-1** published in 2007, by modifying some of the technical contents to ensure consistency among **JIS R 1701-1** to **JIS R 1701-5** and **JIS R 1751-1** to **JIS R 1751-5** which have been established after the publication of **ISO 22197-1**.

The dotted underlines represent the parts modified from the International Standard. A list of modifications with the explanations is given in Annex JA.

1 Scope

This Standard specifies the method to test the removal performance of nitric oxides [NO_x , total of nitrogen monoxide (NO) and nitrogen dioxide (NO_2)], among air purification performances, of the photocatalytic materials supported on the surface of building materials and other products.

This Standard is mainly intended for photocatalysts which are effective in ultraviolet (UV) region within a wavelength range of 300 nm to 380 nm, under solar radiation. To the testing of NO_x removal performance under visible light, the method given in **JIS R 1751-1** shall be applied instead of the method specified in this Standard.

NOTE : The International Standard corresponding to this Standard and the symbol of degree of correspondence are as follows.

ISO 22197-1:2007 *Fine ceramics (advanced ceramics, advanced technical ceramics)—Test method for air-purification performance of semiconducting photocatalytic materials—Part 1: Removal of nitric oxide* (MOD)

In addition, symbols which denote the degree of correspondence in the contents between the relevant International Standard and **JIS** are IDT (identical), MOD (modified), and NEQ (not equivalent) according to **ISO/IEC Guide 21-1**.
