Introduction

This Japanese Industrial Standard has been prepared based on **ISO/TR 2801**:2007, Edition 1, with some modifications of the technical contents in consideration of convenience in usage.

The vertical lines on both sides and dotted underlines indicate changes from the corresponding International Standard. A list of modifications with the explanations is given in Annex JA.

1 Scope

This Standard sets out guidance for the selection, use, care and maintenance of clothing designed to provide protection against heat and flame (hereafter referred to as protective clothing).

NOTE The International Standard corresponding to this Standard and the symbol of degree of correspondence are as follows.

ISO/TR 2801:2007 Clothing for protection against heat and flame—General recommendations for selection, care and use of protective clothing (MOD)
