Assistive products—Toilet seats attachment for squat toilets

1 Scope

This Japanese Industrial Standard specifies the toilet seat attachment for squat toilet among assistive products where the squat toilet can be used as the sit-type toilet by mounting it on the squat toilet (including the toilet placed on the floor which is raised for males to urinate standing behind).

3 Terms and definitions

For the purposes of this Standard, the terms and definitions given in JIS T 0102, and the following terms and definitions apply.

3.1 body

component to support the human body, which is the device (toilet seat attachment for squat toilet) to convert the squat toilet to the sit-type toilet

3.2 lid

component to cover toilet seat

3.3 toilet seat

component to support the human body, which is the plane sustaining the force vertically acting on it mainly during excretion

4 Name of each part

The name of each part shall be in accordance with figure 1.
