Introduction

This Japanese Industrial Standard has been prepared based on the first edition of **ISO 21067** published in 2007 with some modifications of the editorial and technical contents. By comparing the existing edition of this Standard with the corresponding International Standard, this Standard adopts all terms given only in the corresponding International Standard without modifications, and the terms given in both standards with conformations.

The portions given sidelines or dotted underlines are the matters in which the contents of the corresponding International Standard have been modified, or the matters not given in the corresponding International Standard. A list of modifications with the explanations is given in Annex JA.

1 Scope

This Standard specifies the main terms and definitions for packaging.

NOTE: The International Standard corresponding to this Standard and the symbol of degree of correspondence are as follows:

ISO 21067:2007 Packaging—Vocabulary (MOD)

The symbols which denote the degree of correspondence in the contents between the relevant International Standard and **JIS** are IDT (identical), MOD (modified), and NEQ (not equivalent) according to **ISO/IEC Guide 21-1**.
