This Japanese Industrial standard was established in 2008.

1 Scope

This Standard specifies main terms relating to environmentally conscious packaging.

NOTE: Annex A shows relationships between main general terms of environmentally conscious packaging for information.

2 Classification

The classification of terms shall be as follows.

- a) General terms of environmentally conscious packaging
- b) Packaging materials
 - 1) Concerning to paper and cardboard
 - 2) Concerning to plastics
 - 3) Glasses, metals, etc.

3 Terms and definitions

The terms and definitions shall be as follows.

In addition, their corresponding English terms are shown for information.

NOTE: If two or more terms are put down in one column of the term, the preceding term shall be preferentially used in the disclosed order. In addition, a term in parentheses shall not be used as far as possible.
