Introduction

This Japanese Industrial Standard has been prepared based on the first edition of **ISO 24034** published in 2005 and Amendment 1 (2008) with some modifications of the technical contents.

The portions given sidelines or dotted underlines are the matters in which the contents of the corresponding International Standard have been modified. A list of modifications with the explanations is given in Annex JC. Annex JA and Annex JB contain matters that are not given in the corresponding International Standard.

1 Scope

This Standard specifies the solid rods (hereafter referred to as "rods") and solid wires (hereafter referred to as "wires") used for TIG welding, MIG welding, plasma welding, electron beam welding and laser welding of titanium and titanium alloys.

NOTE: The International Standard corresponding to this Standard and the symbol of degree of correspondence are as follows:

ISO 24034:2005 Welding consumables—Solid wires and rods for fusion welding of titanium and titanium alloys—Classification and Amendment 1:2008 (MOD)
